

Photographer Partnership Agreement

This Photographer Partnership Agreement (“Agreement”) is made between:
Crafted Memories Photo Albums LLC (“Company”)
and

_____ (“Photographer”)

1. Purpose of Agreement

The purpose of this Agreement is to establish a professional partnership in which the Photographer refers clients to the Company for custom album design and printing services, and the Company provides preferred pricing, white-label design support, or revenue-sharing options.

2. Roles & Responsibilities

Photographer Responsibilities:

- Provide client photos in high resolution
- Secure client permission to share images with the Company
- Communicate client album requirements
- Review album drafts (optional)
- Ensure timely delivery of required materials

Company Responsibilities:

- Provide professional album design and printing services
- Maintain quality standards across all products
- Provide proofs to Photographer or client for approval
- Deliver printed albums according to agreed timelines
- Maintain confidentiality of client materials

3. Ownership & Copyright

- Photographer retains copyright over their original photos.
- Company retains ownership of album layouts and design templates.
- Photographer must confirm that clients have given permission for use of their images.

4. Pricing & Compensation

Choose one or more options (to be selected mutually):

Option A — Wholesale Pricing Plan:

Photographer receives discounted rates on albums and sells at their own retail price.

Option B — Revenue Sharing:

Photographer receives _____% commission on albums purchased by referred clients.

Option C — White-Label Service:

Company designs albums under Photographer’s branding with no Crafted Memories logo.

5. Payment Terms

- Invoice is issued at the time of order approval.
- Payments are due before printing begins.
- Late payments may delay production and delivery.

6. Turnaround Time

Typical timelines:

- Design: 3–10 business days
- Revisions: based on Photographer or client feedback
- Printing: 5–12 business days
- Shipping: 3–7 business days

Rush options may be available for an added fee.

7. Confidentiality

Both parties agree to maintain confidentiality of:

- Client images
- Personal information
- Project details
- Pricing structures

8. Permission for Marketing Use

Photographer may choose:

Grant permission to use select album spreads or photos for marketing

Do NOT grant permission

Separate Photo Usage Release will be used when needed.

9. Term & Termination

This Agreement remains in effect until:

- Either party provides written notice
 - There is a breach of agreement
 - Both parties mutually agree to terminate
- Outstanding payments and orders must be completed before termination.

10. Liability

Company is not responsible for:

- Poor-quality images provided by Photographer
 - Shipment delays by carriers
 - Color variations due to printing processes
- Photographer is responsible for securing client consent to share photos.
